

ADOPTION CONTRACT

This contract is made between _____, the adopter, and C.L.A.S.P.. As the adopter of _____, I acknowledge that I am over 18 years of age and agree to the following terms and conditions:

_____ I understand that I must provide a carrier to transport my pet before it will be released to me.

_____ I will provide adequate and proper food, water, and shelter for this animal every day and will treat it with kindness, respect, and humane treatment at all times.

_____ I agree to take my new pet to a licensed veterinarian within 7 days of adoption for a general check-up at my own expense. I will have any of my new pet's health problems, of a medical and/or behavioral nature, documented in writing by the attending vet. I will keep my new pet current on rabies vaccinations, as required by law, and comply with all licensing requirements. I will also get general veterinary care for my pet at least once a year and as often as any sickness and/or condition warrants it.

_____ If, at any time, I choose to give up my new pet, I understand that I must return it to C.L.A.S.P.. If I give up my new pet due to any medical or behavioral problems, I agree to explain the problem(s) and provide written documentation of such problems to C.L.A.S.P.. If I choose to relinquish this pet and have arranged for another person/family to adopt it, I will relinquish this pet to C.L.A.S.P., along with the name, address, and telephone number of the potential adopter. The adopter shall complete the adoption counseling and adoption agreement provided by C.L.A.S.P..

_____ I will, at no time, sell or abandon this pet, nor will I allow this pet to be used for the purposes of vivisection or experimentation.

_____ I will not allow this pet to, at any time, run at large or create/become a public nuisance. I will pick up after my pet. I will keep some type of identification on this pet, including, but not limited to, ID tags, microchip, and license tags and will make every reasonable effort to find my pet should it become lost or displaced. I will also check public and private shelters, should this pet become separated from me, and make every attempt to promptly retrieve it.

_____ I understand that information given to C.L.A.S.P. regarding this pet by third parties may not always be accurately represented by those parties.

_____ I understand that animals may behave in ways that are not always predictable and acknowledge that C.L.A.S.P. has made no warranties regarding the future condition, temperament, or conduct of this animal. I accept this animal as is, assuming all the risks and responsibilities that accompany pet-ownership, including bites. I fully release, indemnify, and hold harmless C.L.A.S.P., her family, associates, volunteers, agents and servants from any claim, cause of action, or liability of any type/nature, whether known or unknown, that may directly arise out of or in connection with the adoption, care, ownership, maintenance, retention, temperament, conduct or condition of this animal. This waiver does include myself, all of my family members, and descendants from forever seeking any legal action whatsoever against C.L.A.S.P. and it's representatives.

_____ I acknowledge that any breach of this agreement shall require me to relinquish this pet to C.L.A.S.P.
